The WPRC, Inc. January 20th meeting called to order 1:30pm by Jim Knox N5NWC WPRC, Inc. Vice-Chairman. N5NWC is Acting Chairman until the Chairman election at the January meeting.

Jim N5NWC started the meeting with prayer and blessing of all in attendance asking God for guidance and support as we all strive to do the best we can in our efforts to support our fellow amateurs and support our community.

The meeting started with an around the room introduction of everyone in attendance.

1. Jim N5NWC asked to have all new members seated. Elaine K3EMM indicated we had one new member application, David Hunter N3YFO, representing the 145.390 MHz N3YFO repeater located in Johnstown, PA Cambria County. Elaine K3EMM also mentioned that we had received many renewals including new members from the last meeting.

N3XCC Motioned to accept the new member David Hunter N3YFO.

N8PSU 2nd the motion Tom K3WS called for the vote:

Voted Unanimous zero Nays and zero Abstentions

2. Reading of the November Special Meeting Minutes:

Tom K3WS, mentioned the meeting minutes from the November Special meeting were published on the WPRC, Inc. website, Facebook page, and sent to our members via our WPRCNews e-mail list. Receiving no request for corrections and with no one attending today's meeting having any revisions, Kevin WJ8G Motioned to accept the meeting minutes as published.

W3CYO 2nd the motion Tom K3WS called for the vote:

Tom K3WS also mentioned that members should make sure their e–mail address on file with the WPRC, Inc. is accurate so they can receive important WPRC, Inc. information and have a chance to revise notes, and provide valuable feedback between the regular meetings.

Sam W3CYO motioned to accept report. Paul W3PLP 2nd Tom K3WS called for the vote:

Voted Unanimous zero Nays and zero Abstentions

4. Correspondence

Tom K3WS mentioned a lot of membership renewals. We have also received a lot of positive comments related to the new direction of WPRC Inc.

Chuck W3ON mentioned receiving several documents leading to a possible discrepancy related to the proper membership and trusteeship of the Quad County Amateur Radio Club repeater coordination for N3QC 147.315 Mhz. Chuck W3ON mentioned that two membership requests had been received, and processed in error, for the same repeater coordination. Chuck W3ON reported that a search of the records indicates that the Quad County ARC holds the coordination, thus it also holds the membership for this repeater. After a long discussion among the membership in attendance Kevin WJ8G Motioned to send this matter to the WPRC, Inc. Technical Committee and the Frequency Coordinator to contact the parties involved and attempt to resolve the issue.

Joe KR3P 2nd the motion Tom K3WS called for the vote:

Voted Unanimous zero Nays and zero Abstentions

5. Technical Committee Report provided by Kevin Custer WJ8G

Kevin WJ8G announced that a special 7 hour work session was held January 19, 2013 to review the backlog of some 30 open coordination items. Kevin WJ8G complimented Frank N3FB on a job well done on the new database. Kevin noted that he looks forward to the digital era when this is all more automated.

Tom K3WS asked for a round of congratulations to Frank N3FB, Kevin WJ8G, Elaine K3EMM, and Lori KB3GMU for their efforts in the 7 hour Frequency Coordinator work session. The entire group in attendance showed their appreciation with a very loud applause.

Kevin reminded us that the Mission of the WPRC, Inc. Technical Committee is to establish a support mechanism to assist the Frequency Coordinator of the WPRC, Inc. The Technical Committee should help the Frequency Coordinator in his duties, by relieving some of the responsibility for research, coverage prediction, and general logistics among many other aspects of support.

6. Public Relations Report

Jim N5NWC gave a brief public relations activity report indicating that he felt that everything was going smoothly. He sated that he did not have much more to report.

7. Old Business

Kevin WJ8G reported that, after a search of records provided by Elaine K3EMM, that Bill Timmins N3DDY was found to be in fact deceased. Kevin WJ8G further reported that there is a document stating that Robert Korbar N3MWD was to be the Trustee of 443.900 N3MWD repeater. Joe KR3P asked if there was a record of a backup trustee. Kevin WJ8G reported that a search of records showed that there is no backup trustee.

Kevin WJ8G motioned to approve final coordination of N3MWD. Jeff N8PSU 2nd the motion.

Tom K3WS called for the vote:

Voted Unanimous zero Navs and zero Abstentions

Jim N5NWC, gave a last call for old business. Cynthia WB3CNJ who had just arrived and was seated, stated an item of old business.

Cynthia requested status on her interference complaint regarding operations on 147.000 MHz by N8AD, located in Fairview PA, reportedly causing some interference to the users of the 146.985 KB3PSL repeater.

Tom K3WS asked Cynthia WB3CNJ to resend her original correspondence, as there appears to be no record received by The WPRC, Inc. Chuck W3ON asked if Cynthia or her group had attempted to contact N8AD and if so asked if Len N8AD was he ignoring their attempts to contact him. Cynthia responded "pretty much" Cynthia stated N8AD was "broadcasting HF on 147.000 Mhz" as reported to Cynthia, by Gerald KA6VPZ of Fairview PA.

Kevin WJ8G commented that it is Cynthia's or her group's responsibility first to actually contact N8AD, and document each attempt. Tom K3WS verified N8AD's e-mail address to be correct on www.qrz.com.

Tom K3WS asked that Cynthia send any information she may have on the interference to sec@wprcinfo.org. Cynthia WB3CNJ completed and turned in a WPRC, Inc. Official Record of Interference form Log number 3434.

Tom K3WS stated that any information actually received will be acknowledged, logged, and turned over to the WPRC, Inc. Technical Committee and it will receive priority attention within the guidelines of the WPRC, Inc.

Post Meeting update January 23, 2013 12:59am. After an e-mail exchange started by Tom K3WS with Len N8AD and Kevin WJ8G, Kevin WJ8G has reported that Len N8AD has agreed to move his 2 meter operations from 147.000 MHz to another frequency and apologized for any inconvenience.

8. Bylaws Committee Report

Jeff N8PSU presented information regarding the ByLaws Committee work in progress. The committee consists of Jeff Blake N8PSU, Carmine Prestia K3CWP, Alan Carnes N3FJU, Elaine Bailey K3EMM, and Cynthia Rushton WB3CNJ. Jeff also noted there has been no reply from Cynthia WB3CNJ in any attempts to contact her as a member of the committee.

Jeff N8PSU reported that he hopes to have a base bylaws document for review in the next month or so. The committee intends to utilize the new document, and wants membership input, to develop a final document that reflects operational efficiency, minimizes conflict potential and emulates an efficient structure.

General concepts include updating membership definitions and criteria, improving clarity surrounding the voting privileges of members. Additionally, the committee is discussing the addition of regional representatives to expand member representation on the board of directors. This topic will be clearly defined in the proposed bylaws document. It is clear there are multiple language conflicts in the existing constitution that, under certain circumstances, can promote and perpetuate conflict.

Jeff N8PSU complimented the transition into the new electronic automation under the leadership of Elaine K3EMM. Jeff N8PSU also highly recommends the WPRC, Inc continue to attend ham fests. Jeff N8PSU then asked for your comments and support to be sent to N8PSU@verizon.net. Jeff N8PSU reported that he hopes to be able to review a draft bylaws document at the April meeting.

9. WPRC Incorporation Status 501 c 3

Jeff N8PSU, who has handled this issue very well, reminded us that WPRC, Inc. is now officially incorporated and our non profit status will be outlined in our new bylaws.

10. Return of WPRC property

Scott N3XCC asked Joe KR3P for the transfer status of www.wprc.us to WPRC, Inc. ownership. Joe KR3P said it would be completed this month.

11. New Business

Frank N3FB the WPRC, Inc. Frequency Coordinator, thanked the team, as mentioned above, who worked with him on January 19th to help complete a lot of frequency coordination research work.

Frank N3FB read off several items and summarized some with individual resolutions. It is also noted that all coordinations listed below are in provisional decoordination status with many of them going back into the available pool on June 20, 2013. Tom W3SF stated that he thought that this good time limit before decoordination would occur. Frank N3FB noted that all listed were form returned frequency coordination surveys in which the correspondents reported that they were never going to use the coordination in the future. Bill N3BPB made the suggestion to limit provisional decoordination status to 6 months.

It was noted that just about every member in attendance made a comment related to many aspects of the conversations held related to the various cases in this bulk processing. It was with the support of all attending members we were able to come up with closure on some of the items.

12. W3UDX 147.360 Move 5.25 miles coordination correction

Kevin WJ8G mentioned some details regarding this frequency coordination. Kevin reported that, based on the survey received it appeared that the repeater had changed location, and thus new coordination parameters were noted that the repeater moved 5.25 miles from its previous coordination. After a lot of group discussion based of general questions.

Kevin WJ8G motioned to approve coordination move W3UDX 147.360 Mhz.

Joe K3RP 2nd the motion. Tom K3WS called for the vote:

13. Douglas W2CU no longer has affiliation with listed repeater W3ZIC.

Douglass Sturtz W2CU reported, via email, that he no longer has any affiliation with the Fort Venango Mike & Key W3ZIC club repeater. The frequency coordinator reported the trustee has already been transferred to backup trustee Jim Clinefelter N3BAT, although he has not returned the frequency coordination survey yet.

Bill K3BPB motioned to update WPRC, Inc. coordination records also notifying the Trustee and backup Trustee. This motion followed the recommendation of the Technical Committee.

Jeff N8PSU 2nd the motion. Tom K3WS called for the vote:

Voted Unanimous zero Nays and zero Abstentions

14. Frank N3FB in closing noted there is a lot of Frequency Coordination work to be done and a lot of data to be sent to other local councils. Thank you everyone for your help, support, and patience.

15. Open Frequency Coordination Surveys

Chuck W3ON asked for a closure date on the 33 remaining open surveys.

A lot of discussion and good suggestions came from Kevin WJ8G, and others in the audience, concerning unresolved issues and individuals via mail, our attendance at ham fests, and polling other informed members with a list of issues. Jeff N8PSU noted that he feels that we should do a yearly frequency coordination sampling rather than a 10 year survey. Paul W3PLP suggested that we review the initial list now at the meeting. Scott N3XCC stated that he thought that this was a good idea.

Tom K3WS called for a 10 minute restroom, and refreshment break.

Upon reconvening, the original list of 39 items was narrowed down to the following 27 unresolved or no response to the frequency coordination surveys. Tom K3WS mentioned that if no contact is made and the listed coordinations are not properly claimed, they will go back into the available frequency pool on June 20, 2013.
