I would also like to personally thank each member in each committee who also have done much more work than any of us will ever realize. We as a unified group truly have accomplished a lot in a short period of time. Not all of you may be happy with some of our decisions but the great majority has offered positive progress reports.

You will notice Scott N3XCC will be passing out a WPRC, Inc. report card in this meeting. Please take the time to fill it out and return it to him.

I decided after being elected to call a special meeting in November of 2102 so that our efforts starting 2103 would be positive and efficient. In the November Special meeting we were able to iron out most of the issues that would have surely set us back from have a good start of 2013. While serving as the Secretary we logged and processed 294 items of official business among many non official items.

Working with the newly formed committees we worked hard to automate a lot of the paper portion of processing WPRC, Inc Business. Including efficient meeting note completion and distribution. 2014 will be a year of automation and streamlining processing.

With our experience we provided technical assistance and data support as needed throughout the year.

# Frequency Coordinator - Frank N3FB

We have approved 27 requests from surrounding coordination bodies. This process has become one of the easier ones for me to respond to as it was the first that I had to create a system for.

We have acted upon 44 coordination requests, of those we have issued 39 initial coordinations and 19 of those became final coordinations in 2013. I have managed to get caught up through September for most of the requests. For me this is a slow and deliberate process. I am still learning methods to this process and it will take me a while to process each application.

Survey reports continued to trickle in in the early part of the year, this information is critical in keeping the database updates to afford protection to your repeaters.

Early in the year I responded to the ARRL repeater directory and updated all of the machines listed in the book. This process is about to begin again for this past year.

I have continued to improve a database of system information using Microsoft Access. It can export a file that is capable of generating a kml file for Google earth. This has been the first line of checks for new applications. If the spacing is close, a check using the FCC's distance and bearing locator is performed.

I also have added a table in the database to track changes to coordinations. This is working well. I still need to develop a few forms for data entry and processing and timely reminders.

Thank you for allowing me to assist the council in this capacity and I have hopes that I will be able to create systems that will allow for better tracking of information.

Paul W3PLP asked if anyone needed a restroom break if not we will move on. On we went...

Bill N3BPB commented "It is amazing form my point of view and many others here to see the 180 degree change in the WPRC, the cooperation, the openness, the transparency, it is unbelievable. It makes me feel warm."

The entire room applauded.

## 7) Committee Reports

a) Technical Committee - Kevin WJ8G

I have been involved in building and coordinating repeaters in the WPRC defined section since 1979. In 1991 I ran against Joe McElhaney for position frequency coordinator, but didn't make it. Sometime in late 1998 I submitted a request to change standard the PL tone in the south-east quadrant from 146.2 to 123.0 Hz. In the January 1999 meeting of the WPRC, Sam - W3CYO and Paul - W3PLP motioned that standard be changed to 123 Hz, and the motion carried. Later in 1999 I helped on a topic of whether or not mobile cross-band repeaters were required to identify, as well as other operating parameters. In

January of 2000, I was appointed as one of the first six Regional Coordination Assistants (RCA's), along with Jim - N5NWC and Paul - W3PLP.

A year ago I proposed the reformation of a Technical Committee to assist the Frequency Coordinator with his duties. Acting Chairman Paul - W3PLP appointed me as Technical Committee Chairman. At the time, I wasn't sure if that was done in spite - or in the best interest of the WPRC...

Over the past year, we had a special 7 hour work session that was held January 19, 2013 to review the backlog of many open coordination items. That work party consisted of Frank and Lori, and Elaine and I. I recognized Frank on a job well done, especially where the new frequency database was concerned. The Technical Committee should help the Frequency Coordinator in his duties by relieving some of his burden on research, coverage prediction, and general logistics, among the many other aspects of frequency coordination.

Cynthia - WB3CNJ reported about interference to the 146.985 repeater.

In a post meeting update January 23, after an e-mail exchange started by Tom K3WS with Len N8AD and myself, I reported that Len N8AD has agreed to move his 2 meter operations from 147.000 MHz to another frequency and apologized for any inconvenience.

I worked with Jim - N5NWC and several others on the 27 unresolved frequency coordination surveys. I motioned that any unresolved items/frequencies in this list be returned to the coordination pool on June 20, 2103. That motioned carried by unanimous vote.

On a request from Frank - N3FB, I wrote up some correspondence that accompanies initial coordinations, as well as fielded information from/to coordination bodies that surround us concerning two coordination disputes and helped write the resolutions for each of them. Since this time, I have been pre-screening the coordination applications for any inaccuracies, and where necessary I contact the prospective trustee by phone or email to obtain the correct data. This helps streamline the coordination process and help eliminate erroneous data. During this time, I updated several web pages to make them easier to read and understand.

Tom - K3WS made a motion to authorize and task the Technical Committee (lead by myself) with the duty of evaluating and researching the best option to totally optimize the operations of the WPRC, Inc from every standpoint. A budget will be proposed to the board, including web site hosting, design, and updating. I'm still working with Scott - N3XCC and Elaine - K3EMM on this proposal.

I also worked on two reports of interference and their resolve. These include 145.110 between Rochester NY and Warren PA, and the other on 146.610 between Pittsburgh and Altoona.

As introduced as an idea for the board to consider by Elaine K3EMM, is the matter of "Paper Repeaters". In an email received from Wayne - WS3PC on October 1st 2013 informed the WPRC of two repeaters claimed to be off the air - for some time. The repeaters reported were the 146.88 in Coudersport and 147.300 in Smethport.

On October 3rd Paul - W3PLP asked me if I was close enough to either of these locations to establish whether or not either were truly on the air - or not. I told him I was too far away to be sure, but I would take the time to go on an expedition and see. On Sunday October 6th, Elaine and I went on a road trip. We traveled from Warren to Smethport, Coudersport and then to Kane, Leeper, Tionesta, Youngsville and back to Warren.

From that trip, the following five repeaters are confirmed not currently on the air as of October 6, 2013. Smethport - 147.300 Coudersport - 146.88 Vowinkel - 443.375 Tionesta - 145.49 Tionesta - 442.400

The repeaters that were NOT on the air were investigated to the fullest. In all three cases we tried EVERY PL tone and drove within several hundred feet of the coordinated repeater site. We also tested from the town center.

Please note that NOT every coordinated repeater near our travels, or in this quadrant, was tested for on air conformity. That was way beyond the scope of what I was asked to do.

It is my goal as Technical Committee Chairman to assist the Board of Directors and the members of the WPRC, Inc. to continue to make it a better organization.

b) By Laws Committee - Jeff N8PSU

The by-laws committee along with members of the current board have continued to develop the by-laws revisions. While the process is slow, the development of solid language that will carry the WPRC forward is the primary focus. This process removes conflicting language, gives more specific language around membership and organizational function such as establishing standing committees and assistant positions to help process day to day business.

The WPRC became officially incorporated as a PA non profit in early 2013.

It's my expectation that we will bring forward to the membership a final document in 2014 that will survive and keep the WPRC grounded, stable and membership driven!

c) Public Relations Committee - Jim N5NWC and Scott N3XCC

Jim N5NWC mentioned that Scott N3XCC will give this report.

Scott N3XCC, commented on the new WPRC, Inc website and his plans to help streamline its presentation and use. Scott showed the main page on the screen at the meeting indicating this is just a start. Please visit wprcinfo.org and give your input along the way. There will be a member's only area as well.

## 8) Old Business

a) Review on paper reports and some repeaters reported or found to be off air.

This subject received a great deal of around the room discussion and information sharing. Quite a few members in attendance openly participated in this great discussion. This was a very impressive discussion lead by Kevin WJ8G who overviewed a recent drive-out to verify the operation status of several repeaters. In an email received from Wayne - WS3PC on October 1st 2013 informed the WPRC of two repeaters claimed to be off the air - for some time. The repeaters reported were the 146.88 in Coudersport and 147.300 in Smethport.

On October 3rd Paul - W3PLP asked Kevin if he was close enough to either of these locations to establish whether or not either were truly on the air - or not. Kevin told Paul he was too far away to be sure, but he would take the time to go on an expedition and see. On Sunday October 6th, Elaine - K3EMM and Kevin - WJ8G went on a road trip. They traveled from Warren to Smethport, Coudersport and then to Kane, Leeper, Tionesta, Youngsville and back to Warren.

From that trip, the following five repeaters were confirmed not currently on the air as of October 6, 2013.

Smethport - 147.300 Coudersport - 146.88

Vowinkel - 443.375

Tionesta - 145.49

It was reported by Frank - N3FB the Frequency Coordinator that the Trustees for the 147.300 and 146.88 frequencies had responded that while their repeaters were off the air at the time of returning the surveys, they would have their repeaters on the air sometime in 2012. Since neither trustee had established a working repeater in over a year, it was discussed and decided that these two coordinations would be revoked immediately and their frequencies be returned to the pool. It was also discussed and decided that the remaining three would be sent a letter informing the Trustees that they had 90 days, or until the next meeting (which ever came first) to return their perspective repeaters to working operation or they would lose their coordination(s).

This discussion was brought to a motion by Bill - N3BPB, seconded by Paul - W3PLP and carried on unanimous vote.

b) Paul W3PLP appointed Scott N3XCC as WPRC, Inc. Webmaster
